## Product Disclosure Statement (PDS) updates for the Global Systematic Equities Fund (the Fund)

Specialised Private Capital Ltd ABN 87 095 773 390 trading as Centric Capital is the responsible entity (RE) for Global Systematic Equities Fund ARSN 635 318 991. Throughout our regular annual product review, we have made several changes to the Fund, which are detailed below.

This update is a result of our ongoing annual PDS review. The name change aligns with the existing fund structure. Vinva Investment Management Limited is the Underlying Investment Manager, and the Fund invests substantially all of its assets in the Vinva International Equity Alpha Extension Fund.

To reflect the fund structure and fee structure more accurately, the disclosure approach for the *management fee and cost* in PDS will change to one total fee number instead of two components of management fee and indirect cost. In the PDS section 6, Fees and Costs, the Fees and Cost Summary table, under Ongoing Fees and Costs, the disclosure for Management Fees and Costs will change to one total fee number instead of two components of management fee and indirect cost. Total fees and costs remain the same before and after the change. As shown in the table below:
